3:36pm Tony D. and Stacey C. of Turnstone present the Asbestos Testing Subcontractor Recommendation. They presented 3 Subcontractors for review.

FLI Environmental---\$1900.00

Turnstone recommends FLI Environmental.

Morgan H. makes a motion to hire Morin's Landscaping to treat Snow Park for \$1,400.00 to come out of the Jackman Fund.

Motion Passed.

Ken L. recommends that we install a walkway from the stairs at the Columbarium to the road to make it easier to navigate the area and make it easier to clear snow in the winter. Morin's proposed doing the walkway for \$3,786.00.

Morgan H. makes a motion to hire Morin's Landscaping to install a walkway at the Columbarium from the stairs to the street for \$3,786.00 to come out of the Jackman Fund.
